#### **2024-25 School Description and Mission Statement**

Discovery Elementary School is a UTK-5 comprehensive school with four SDC classes. The goal of Discovery Elementary is to educate the whole child by providing access to rigorous core and supplemental content material. Students are given multiple opportunities to learn at the level and time they need while facilitating that scholars engage in critical thinking, communication, collaboration, and creativity.

Discovery's Mission is to ensure that each and every student will be able to learn in a safe, equitable and rigorous environment that embraces diversity.

#### 2024-25 School Description and Mission Statement

Our Vision is that we are a place where we inspire the traits of STARS (Stay Safe, Take Responsibility, Aim High, Respect Everyone, Shine Bright) one day at a time.

Discovery implements the Positive Behavior Intervention and Support (PBIS) program. Expected behaviors are modeled and taught to students and positive behaviors are routinely reinforced. Capturing Kids Hearts (CKH) and Playworks are two frameworks that are also routinely implemented throughout the campus. A recreation leader leads positive and engaging activities during recesses and lunch as well as some PE times. Two full time school counselors, a full time campus supervisor, and a full team of supervision aides promote school safety and supervise students throughout the day. Annually, we evaluate our iReady Diagnostic Data using Beginning of year (BOY), Mid-Year, and EOY diagnostic results as well as CA Dashboard Data to monitor student academic progress. Additionally, we evaluate YouthTruth Survey Data (Staff, Students, and Families), CKH data to evaluate and modify our practice in order to optimize the experiences of each school community partner.

#### General

The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the Los Angeles County Office of Education. #### Maintenance and Repair

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

#### Cleaning Process and Schedule

The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards is available at the district office. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

#### Deferred Maintenance Budget

Although the State no longer requires a Deferred Maintenance contribution, Lancaster School District is still dedicated to maintaining the facilities for our students. These expenditures would include but not be limited to roofing, plumbing, heating, air conditioning, electrical, painting, and flooring. For the 2023-24 school year, the district has budgeted \$2,683,000. for deferred maintenance projects.

#### **Professional Development**

The Lancaster School District provides professional development throughout the school year that trains and supports staff in the effective implementation of our adopted core and cornerstone programs including, but not limited to: Teacher Clarity, PLC+, Standards-Based Grading and Reporting, Structured Literacy, Data Analysis, Leadership Training, Writing Instruction, Coaching, Direct Instruction, Conceptual Development, Building Academic Vocabulary, Culturally Responsive Teaching and Learning (including Capturing Kids Hearts), Integrating Technology into the Classroom, PBIS, Intervention, and Differentiation in Strategies for teaching EL, GATE, and at-risk students. High-quality, ongoing professional development opportunities are recognized as an important component in our work towards continuous improvement in student learning.

Ongoing opportunities include in-services during and after the work day as well as through site and district in-class and on-site coaching. All teachers are provided multiple opportunities to receive optional paid professional development. The school year calendar allows for 37 minimum days in which 26 days are utilized to provide 1-2 hours of district and site designed professional development specific to their needs. Outside workshops, conferences and other in-services that provide more indepth training and further prepare our staff members to become trainers for our district are available as approved by the Board of Trustees.

Professional development supporting our instructional programs and services for students is also provided for our classified staff members. Additionally, workshops designed to improve technology skills, provide training with key software programs utilized in the district, and offer information on personal excellence and social responsibility are included in the professional development course offerings for classified staff throughout the school year.
